STEPS TO COMPLETING THE COMMON APPLICATION

<p>STEP 1 Research</p>	<p> <u>DO NOT SKIP THIS STEP!</u> <i>See Checklist on Reverse Side!</i></p> <p>The first step in completing the Common Application is to research all of the colleges/universities that use the Common Application! Please use the Checklist on the other side of this flyer to begin!</p>

<p>STEP 3 Application FAQS</p>	<p>Application “Help Center” Help Center </p> <p>Common Application does not provide phone assistance. Students may find answers to FAQs in the Application Help Center. If the answer is not provided in this section, they can submit a question by clicking the button titled “My answer is not here.” My answer is not here -></p> <p>Academic Advisor (“Common App” tab)</p> <p>Common Application requires that you to enter a name and contact information for your academic “advisor”— usually this is your Fullerton College counselor. However, if you have not established regular meetings with a Fullerton College counselor, then you can enter the same information that you will provide for the “Academic Evaluator” under the “My Colleges” tab.</p> <p>FERPA Release Authorization (“My Colleges” tab)</p> <p>All applicants MUST complete the FERPA waiver. The FERPA waiver is only completed once and covers all current and future colleges and recommenders. Once a student invites the counselor or recommender, the FERPA selection locks and cannot be changed. It is critical for you to read the entire authorization.</p>	<p>Academic Evaluator (Under the “My Colleges” tab)</p> <p>Common Application requires that you to enter a name and contact information for an academic evaluator, regardless of whether it will be required by a specific college/university! The academic evaluator is usually an instructor, counselor, or other college official who is very familiar with your academic strengths.</p> <p>College Report (“My Colleges” tab)</p> <p><i>IF required</i> by your prospective college (See Step 1), the “Transfer College Report” must be downloaded and delivered to the admissions office of each college/university that you have attended and submitted with a set of official transcripts from that college/university.</p> <p>Additional Forms (“My Colleges” tab)</p> <p><i>IF required</i> by your prospective college (See Step 1):</p> <p>The “Secondary School Final Report” must be downloaded and delivered to your high school from which you graduate and submitted with a set of official transcripts from that high school.</p> <p>The “Mid-Term Report” must be downloaded and delivered to each of your instructors in the courses that you are currently enrolled. Instructors are to provide your current grade for the course.</p>
<p>STEP 4 Submit the Application</p>	<p>SUBMIT YOUR COMMON APPLICATION</p> <ol style="list-style-type: none"> 1. Complete the Common Application 2. Complete the Writing Supplement 3. Complete the Art Supplement (If Applicable) 4. Submit the Common App portion—pay the application fee, sign Common App (type your name), and press <submit>. 5. Submit the Writing Supplement—verify, sign (type your name), and press <submit>. 6. Submit the Art Supplement (If Applicable) <p style="text-align: right;">Revised Fall 2014</p>	

BEFORE YOU BEGIN THE COMMON APPLICATION

Contact your prospective college/university and speak with a college representative who is familiar with transfer admissions and the Common Application!

This checklist provides you with the most important questions you will want to ask the representative!

1. Get the college representative's contact information.
2. **TAKE NOTES!** Use the checklist below to help guide you in your discussion with the college representative.
3. Afterwards, send the university representative an Email thanking them for their time and a **BRIEF** summary of what you covered in your conversation.
4. This will allow the college representative to ensure that you understood all points of the conversation and to clarify anything that you may have misunderstood.
5. **SAVE ALL EMAIL CORRESPONDENCE WITH THE COLLEGE REPRESENTATIVE!** This will provide you with a record of who you spoke with and what was discussed!
